## If you pay tax in the UK

If you are a UK taxpayer, you can make a regular payment to the Diocese in Europe for the work of St Andrew's.

As a UK charity, the diocese can claim 25% of your giving from HM Revenue & Customs. After a small contribution to support the administrative costs of the diocese, a monthly donation of £100 given by Gift Aid benefits St Andrew's by £1,485 per year. If you are a higher rate taxpayer, you may also be able to claim a tax deduction.

To make a regular contribution by Gift Aid, please use you electronic banking to set up a regular payment to 'The Diocese in Europe Fund' at Barclays Bank plc (sort code 20-06-13) account number 40317039 referencing your payment 'Pau Gift Aid' and complete the attached form and return to our treasurer to pass on to the diocese in London.
